2. Review from the Assessor

◆General review

Two of the examinees were well experienced and took charged for practical test well as an assessor. I can be said that they had the ability to perform properly as a skill assessor and conducted appropriate skill assessment. There were 6 examinees, all of them came to KMK every day and studied while observing the examination situation at the examination site with the 2 main candidates. I felt their feelings for this examination were positive. Moreover, we were chatted with examinee when we collected their survey. They said as "the examination made us very nervous". We think as they were under presumed at that time and how this examination was an important for them. Five of the six examinees were member of received training five years ago with my training. Since then, their skills have improved and I felt greatly they would like to improve as an assessor. I would like them to further develop this Industry of Grinding machine in the future. This is a first time, an assessor certification of the grinding machine was conducted and the first assessors were certified. I would like examinees to become leaders of the Industry and I would like them to train more people for human resource. It's still a start and I am expecting them for success in the future.

◆About future training

- ① As of October 2017, Jakarta has still have heavy traffic congestion. Chronic traffic jams continued from the airport, usually it took 2 hours from Airport to KMK; however it actually took more than 3 hours 30 minutes. Two of examinees were late on the first day due to traffic congestion. It took two hours to get everyone ready to start examination. We need to consider choosing Hotel in the future.
